Financial Aid: FAFSA

What is it?

FAFSA- Free Application for Federal Student Aid

The FAFSA is an online application that sends you and your parent's information to schools in order for them to decipher how much money you need for school.

Remember- the FAFSA does not decide how much money you get, the schools do.

Therefore, it is important to apply to multiple schools in order to have more financial opportunities

Who is eligible

The FAFSA is only available to students with US Citizenship, Permanent Residency, or certain visas. The FAFSA is available to students regardless of their parents citizenship status.

HOWEVER,

If students do not meet these requirements, they can still file the TASFA and receive state financial aid to help pay for college.

What do you get?

The FAFSA application is an application for all different kinds of aid, such as,

Federal Loans

Grants - Federal, State, and Institutional

Work Study

How do you do it?

The FAFSA requires that you use your parents tax information if you are considered a dependent student.

What does "tax information" mean?

- Tax return form 1040, 1040A, 1040EZ, etc.
- W2s

Need tax help?

Foundation Communities- free help for low income families

Lifeworks- pleasant valley road- help with taxes and FAFSA/TASFA

Talking to parents about FAFSA

- Free money is available to students that qualify
- MOST students qualify for some type of financial aid
- Financial aid application requires both student and parent information
- It can seem complicated, but often the form can be completed in about 30 minutes
- Financial Assistance for college is available!
